SHP notes June 30, 2023:

Disclosure of notes on shareholding pattern - Tata Sons Private Limited i.e. TSPL holds 31.90% of Equity Shares of the Company. TSPL, being a Core Investment Company registered with the Reserve Bank of India, is exempted from the Companies (Significant Beneficial Owners) Rules 2018, as amended from time to time, on investment made by them. Other than TSPL, no shareholder holds 10% or more of paidup Equity share capital of Company.

Disclosure of notes in case of promoter holdings in demat form is less than 100 % - The difference of 50 shares of Rs 10 each which are not held by promoter in dematerialised form is on account of Writ Petition no 1478 of 1995 filed by Rajnandini Pachasia in the High Court of Calcutta. The matter is pending in the Court and the final order is awaited. Hence Tata Sons Private Limited has not been able to dematerialise the said 50 shares
