Notes to the financial statements for the year ended 31 March 2016

1 Significant accounting policies

Basis of accounting

The financial statements have been prepared under the historical cost convention and in accordance with International Financial Reporting Standards (IFRSs) as adopted by the European Union.

Financial instruments

Financial assets and financial liabilities are recognised in the company's Balance Sheet when the company becomes party to the contractual provisions of the instrument.

Financial assets

Financial assets are classified according to the nature and purpose of the financial assets and this classification is determined on initial recognition. As at the reporting date all financial assets are categorised as loans and receivables and measured at amortised cost less any impairment. Financial assets are assessed for indicators of impairment at each Balance Sheet date. Financial assets are impaired where there is objective evidence that, as a result of one more events that occurred after initial recognition of the financial asset, the future cash flows of the investment have been impacted.

Equity

Equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the asset of the group after deducting all of its liabilities. Equity instruments issued by the company are recorded at the proceeds received, net of direct issue costs.

2 Profit and Loss Account

No Profit and Loss Account is presented with these financial statements because the company has not received income or incurred expenditure during either the year under review or the preceding financial year. Furthermore there have been no items of other comprehensive income and therefore a statement of comprehensive income is not presented.

3 Statement of Cash Flows

The company has not prepared a Statement of Cash Flows as there have been no cash movements during the year.

4 Information regarding directors and employees

The company had no employees during the current and preceding year. No emoluments were payable to the directors of the company during the current and preceding financial year.

5 Amounts owed by group undertakings
