




Consolidated Financial Performance (10 year)

- 10 Year Tax holiday after commencement of commercial production and 10% concessional rate thereafter




Investment in Potash project in US

- 4. EPM Mining Ventures also has 40 per cent stake in Emerald Peak Minerals, which controls 6,409 acres of land leased from the State of Utah and is contiguous to its land.
