**NOTICE OF EXTRAORDINARY GENERAL MEETING AND  
E-VOTING INFORMATION**

NOTICE is hereby given that the Board of Directors at the meeting held on November 22, 2016 decided to convene an Extraordinary General Meeting (EGM) of the Members of Tata Chemicals Limited ('the Company'), on the requisition of Tata Sons Limited, which holds 19.35% of the paid-up Equity Share capital of the Company. The EGM will be held on Friday, December 23, 2016, at 3.00 p.m. at the Birla Matushri Sabhagar, 19, Sir Vithaldas Thackersey Marg, Mumbai - 400 020 to transact the business, as set out in the Notice of the EGM. The Notice of the EGM along with Attendance Slip and Proxy Form has been e-mailed to members whose e-mail addresses have been made available by the depositories or are registered with the Company. Physical copy of the EGM Notice along with Attendance Slip and Proxy Form has been sent by permitted mode to members who have not registered their e-mail address. The Company has completed the dispatch as well as sending of email to the members on November 28, 2016. Notice of the EGM is available on the website of the Company at [www.tatachemicals.com](http://www.tatachemicals.com) and on the website of National Securities Depository Limited (NSDL) at <http://www.evoting.nsdl.com/>.

Pursuant to Section 108 of the Companies Act, 2013 and Rules framed thereunder, as amended from time to time and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Members are provided with the facility to cast their votes on the resolutions set forth in the Notice of the EGM using electronic voting system from a place other than the venue of the EGM ('remote e-voting') provided by NSDL and the business may be transacted through such remote e-voting.

The voting rights will be on the basis of shareholding as on the cut-off date, i.e. December 16, 2016. Any person who is a Member of the Company as on the cut-off date is eligible to cast vote on all the resolutions set forth in the Notice of EGM using remote e-voting or voting at the EGM.

The remote e-voting period commences on Tuesday, December 20, 2016 at 9.00 a.m. IST and ends on Thursday, December 22, 2016 at 5.00 p.m. IST. During this period, Members may cast their vote electronically. The remote e-voting module shall be disabled by NSDL thereafter.

Once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently.

The facility for voting through electronic voting system or ballot paper shall also be made available at the EGM and Members who have not already cast their vote by remote e-voting shall be able to exercise their right at the EGM. The Members who have cast their vote by remote e-voting prior to the EGM may also attend the EGM but shall not be entitled to cast their vote again.

A person who has acquired shares and become a Member of the Company after the dispatch of notice of EGM and holding shares as on cut-off date, may obtain the login ID and password by sending a request at [evoting@nsdl.co.in](mailto:evoting@nsdl.co.in). However, if the person is already registered with NSDL for remote e-voting then the existing user ID and password can be used for casting vote.
