15th **May, 2020:** Tata Chemicals Ltd. (the "Company") today declared its Financial Results for the fourth quarter and financial year ended March 31, 2020.

For FY19-20, the Company reported income from operations on a consolidated basis at ₹10,357 Cr, with net profit of ₹1,028 Cr, down by 12 percent. On a standalone basis, income from operations was at ₹2,920 Cr, with net profit at ₹672 Cr, up by 7 percent.

For the quarter ended 31st March, the Company reported consolidated income from operations at ₹2,378 Cr, Standalone income from operations reported at ₹734 Cr.
