It is clarified that votes may be cast by Members either by postal ballot or e-voting and casting of votes by postal ballot or e-voting does not disentitle them from attending the Meeting. Member after exercising his right to vote through postal ballot or e-voting shall not be allowed to vote again at the Meeting.
