1. Basis of Presentation

Description of Business

General Chemical Canada Holding, Inc. ("Company") is an inactive corporation. It is a subsidiary of NHO Canada Holding, Inc. ("NHO"), which is a subsidiary of Tata Chemicals North America Inc. ("TCNA").

2. Summary of Significant Accounting Policies

Use of Estimates
