With reference to the captioned subject, we would like to inform you that the Company has received an Order from the Office of the Asst Commissioner (ST), Chennai, Tamil Nadu levying a penalty of ₹ 30,33,904/- under the Central Goods & Service Tax Act (CGST Act) / Tamil Nadu Goods & Service Tax Act (TNGST Act) & Rules framed thereunder.

Based on the merits of the matter, prevailing law and the advice of the counsel, the Company is planning to appeal against these orders before the appellant authorities and reasonably expects favourable orders from the appellant authorities.
