TENDER INVITATION NOTICE

Tata Chemicals Magadi Limited ("hereinafter referred to as TCML") invites sealed applications from eligible firms for purposes of awarding to the most compliant to provide transport services.

Alongside your bid, please submit copies of certificates of your firm's affiliations, full company profile and referrals if any.

The bidders must submit their financial proposals in separately sealed envelopes but preferably enclosed in one outer envelope clearly marked:

Deliver to the Tender Box located at the Reception in Administration block at Lake Magadi or drop at our collection centre at Avon House on Enterprise Road Industrial Area opposite New KCC on or before **Friday 3rd May 2019**

PART A – FINANCIAL PROPOSAL

- The vehicles must be comprehensively insured
- The supplier shall provide the vehicles not older than 5 years and a driver for the said services as directed by the client.
- Fuel and any other requirements for the vehicle shall be the responsibility of the supplier
- TCML will set out the daily program of the duties to be done for the day, along the said routes and engagement is for 8-10 Hours per requirement communicated 24 Hours prior by TCML.

The bidders should submit their financial proposals in separately sealed envelopes but preferably enclosed in one outer envelope clearly marked **“TENDER FOR THE PROVISION OF TRANSPORT SERVICES ALONG THE RAILWAY LINE”** to reach us on or before 1700hrs 3rd May 2019

SPECIFICATIONS FOR BUS TO TRANSPORT PERMANENT WAY STAFF ALONG THE RAIL

- a) Able to carry 35 seated passengers.
- b) Has luggage compartment to carry tools and light maintenance equipment under the vehicle.
- c) The vehicle should be clean roadworthy and well maintained.
- d) Vehicle must be able to easily move on the terrain of the roads between Konza and Magadi.
- e) The transporter should undertake to transport the P/way workers from its Kajiado or Magadi premises to various locations along the railway line.
- f) The transporter should provide bus with 24 hours prior notice at either location (Kajiado/Magadi) at 0630hrs to be able to depart by 0700hrs. After the shift, the buses will be made available to the workers to transport them back to their home stations.
- g) The buses provided by the transporter should be in good condition and the drivers should have valid driving licenses for the particular class of vehicle together with valid insurance cover and transportation permits as per NTSA.
- h) The Company will be authorized to inspect the condition of the buses, insurance cover of each bus and driving license of the drivers of the bus. The transporter will arrange to produce the said documents to the Company.

- i) The transporter shall indemnify and keep indemnified the company against any loss, costs, charges, damages and expenses incurred or suffered by the Company on account of the transporter not having valid licenses, permits or its drivers not having valid driving licenses.
- j) The transporter will take all precautions for protecting the Company's employees and workers from accident. The transporter will be responsible for any loss, claim, costs, charges and expenses incurred or suffered by the Company on account of any injury, loss or death of its employees or workers due to accident in the bus or any other reason relating thereto.

SAFETY REQUIREMENTS

- k) There shall be pre-use inspections done by TCML before engagement of the client's vehicle and regular periodic inspections. The checklists will include all safety related required items.
- l) Drivers must be trained, certified and medically fit to operate the class of the vehicle.
- m) Driver shall obey speed limits and applicable TCML site rules.
- n) Drivers may not commence a journey until they have their own seat belt fastened and those of passengers too.
- o) Driver should not drive if ill, physically impaired or fatigued to an extent that would make vehicle operation unsafe.
- p) No driving is permitted by staff under the influence of alcohol or drugs. If drivers need to take medicines (either prescribed or over the counter) that render them unable to operate their assigned vehicle safely, they are to immediately inform their Line Supervisor.
- q) Driver should not engage in any activity that would detract from attentive driving.

TERMS OF PAYMENT

- a) Issue invoice on a monthly basis for services rendered during the month.
