SERVICE LEVELS AND KEY PERFORMANCE INDICATORS

- . Guards shall be well disciplined and of high integrity, already trained and regularly trained on guarding services and investigation of crime.
- . The guards shall have radio communication gadgets for ease of communication and quick response to emergencies.
- . The Service provider shall make available panic alarms to alert other security providers within the operation area e.g. KPA security and Port police in the event of emergencies alerts in Mombasa.
- . A log- in point within area of operation shall be availed, to ensure that the patrol guards log in every time during patrols or when on normal duty.
- . Guards on duty shall at all times be in Safety compliance equipment among them uniform, port passes in Mombasa, reflectors, helmets and safety shoes.
- . Guards while on duty SHOULD have search and detecting equipment for both visitors and Vehicles coming to TCML operation areas.
- . The guards shall be literate and able to maintain all the registers at the points of entry and exit within TCML operation areas.
- .The Security service provider must provide relievers and in charge guards who will be tasked with discipline and general order of the guard force.
- .Magadi and Kajiado guards shall double up as fire standby fighters and hence should have additional training on firefighting skills. Proof of training MUST be evident.
- .CCTV manning and operations training is mandatory for the control room controllers.
- .Capacity to provide properly trained dogs and handler at Mombasa site.
- .Trained tallying clerks to handle product tallying and dispatch.
